

Introduction to Agenda 2063 Special Project



- The Executive Council Decision EX.CL/Dec.1164(XL) called upon AUC and AUDA-NEPAD to lead the Evaluation of Agenda 2063 FTYIP and development of the next Plan (dubbed "the Special Project"). The Special Project has two components:
 - The Evaluation of the First Ten Year Implementation Plan (FTYIP)
 - Development of the Second Ten-Year Implementation Plan (STYIP)
 - The two process are undertaken concurrently and the reports presented to the AU Assembly in February 2023.





Special Project Objectives




The overall objective of the Project is to assess Africa's performance and progress along the 20 goals and targets of the FTYIP and to formulate the STYIP.

More specifically, the Special Project seeks to:

- Assess the level of achievement of the targets set in the FTYIP at country, regional and continental level;
- Assess the performance of AU Organs, Agencies and RECs in coordinating, managing partnerships and mobilizing resources for Agenda 2063 FTYIP;
- Assess the progress in the implementation of AU flagship Projects;
- ❖ Propose areas of priority focus in the STYIP (2024-2033) based on the lessons learnt from the implementation of FTYIP (2014-2023) and
- ❖ Formulate the next FYIP (2024 2033) of Agenda 2063

SCOPE AND METHODOLOGY

- The Scope of work will be based on the FTYIP Results Framework (Aspirations, Goals, Priority Areas, Targets, Core Indicators) and the flagship projects
- Supportive functions such as coordination and partnership arrangements will be assessed



- The Project will be implemented across all the AU Member States, RECs and other AU Organs
- The process will be consultative with clear roles and responsibilities for Member States, RECs and other AU organs and other Pan-African institutions
- An appropriate mix of methods will be applied to ensure credibility while adhering to evaluation (relevance, efficiency, effectiveness, impact and sustainability) and strategic planning norms
- International standards and best practices (incl. participatory & consultative) will be observed throughout the two interrelated processes.
- An Independent Firm will work with the AU-TWG on the evaluation of the FTYIP
- The Formulation of the STYIP will draw from the biennial reports and the FTYIP evaluation

- 3. Data mining Desktop exercises

Component 3: Analysis and historical-foresight

- Specialised studies /investigations and analytical work (incl Cost:Benefit analysis; Budget analysis; Implementation capacity) commissioned through specialised agencies/institutions
- 2. Engage AU Specialised Agencies for technical thematic input/submissions
- 3. Engaging with lead entities on AU Development Policy Frameworks [CAADP, AfCFTA; STISA-24; etc....]
- 4. Expert analysis / progress assessment of the 15 Agenda 2063 Flagship Projects

Preparations for the Evaluation of the FTYIP and Formulation of the STYIP of Agenda 2063

- The Special Project was launched on 30th June at the meeting of the Ministerial Follow-up Committee on Agenda 2063 attended by ministers of planning
- Emphasis was placed on ensuring inclusiveness with participation of state and nonstate actors – especially at country-level
- As part of the data collection methods, national multi-stakeholder consultations will be held in all AU Member States, from July to mid-September 2022
 - Orientation sessions for national focal points will be held during the week of 25 –
 29 July 2022, conducted online in all the five regions of Africa
 - Country-level consultations with state and non-state actors (women, youth, private sector etc) on FTYIP and STYIP will be held, culminating into national consultation reports

... national multi-stakeholder consultations...

Overview of the National Multi-Stakeholder Consultations

- Agenda 2063 embodies the aspirations of the African people. The evaluation of the first decade of its implementation and the preparation of the successor plan will adopt a people-centred approach with state and non-state actors at country-level playing a critical role.
- In this regard, national multistakeholder consultations will be held in all the 55 AU Member States
- The consultations will serve as platforms for collective reflection on the execution of the first decade of implementing Agenda 2063 and as well a channel for eliciting country-level views on the focus and implementation considerations for the successor plan.
- The multi-stakeholder consultations will culminate into national consultation reports that will highlight key lessons learnt in the implementation of Agenda 2063 FTYIP, and as well articulate priority development areas for the successor plan

 Coordinate group-specific consultations on the evaluation of the First Ten Year Implementation Plan and priorities for the successor ten-year plan

 Organise 1 day multi-group consultations analysing all the group inputs and prepare a synthesis and consolidated national consultation report

One day Multistakeholder Dialogue

- Attended by entities/institution representatives of:- Policymakers (Planning, Finance, statistics, and sectors), Women groups, Youth, Private Sector, Media houses, Academia, Diaspora, Civil Society etc)
- Organized by ministries of planning with support of AU-TWG, RECs, AfDB, UNDP and other UN entities at country level
- Presentations made by each stakeholder group and inclusive discussions on submission of stakeholder dialogue reports

Preamble (to feature on every group-checklist of questions)

- Agenda 2063 is Africa's 50-year development blueprint for inclusive growth and sustainable development, adopted, in January 2015. The Agenda that embodies the seven aspirations of the African people is implemented through five 10-year implementation plans.
- The First Ten Year Implementation Plan that commenced in 2014 comes to an end in 2023. To this end, the African Union Executive Council called for the evaluation of the First Ten Year Implementation Plan and the development of the successor ten-year plan of Agenda 2063, dubbed "the Special Project". The report of the FTYIP and the plan of the successor ten-year plan will be presented to the AU Assembly in February 2023.
- As a key measure for deepening ownership and collective responsibility of Agenda 2063, the execution of the Special Project will be characterised by inclusive national consultation processes that will embody joint assessment, reflection and learning among state and non-state stakeholders especially at country-level.
- The national multistakeholder consultation processes will be guided by a set of specific questions for the various stakeholder groups. The outcomes of the consultations from all groups will be analysed and a synthesis national consultation report prepared by the Ministry in charge of national planning and submitted to AUC and AUDA-NEPAD latest 15 September 2022
